

Dear Parent and Guardian:

Thank you for your interest in the Wild About Wildlife Virtual Summer Camp. We are excited to offer this summer camp experience virtually to camp groups. Our goal is to provide entertaining summer fun and it is up to your camp coordinator to decide how much of the programming your child's camp will access throughout the week. Wild About Wildlife Virtual Summer Camp is designed to boost your child's awareness of his or her surroundings, learn about wildlife and most importantly, have fun!

The camp uses a variety of online third-party video conferencing services and video streaming channels to present the fun and creative sessions. In some cases, offerings will require children to be on a live video conference that may be recorded. Please read through the following guidelines so we can maintain a safe experience for all participants who access and participate in Wild About Wildlife Virtual Summer Camp activities.

- 1) After your camp coordinator registered for a Wild About Wildlife Virtual Summer Camp session, they received an email confirmation acknowledging that they have successfully registered. In addition, they received a link to this downloadable/printable letter and waiver and release forms for parents of their campers to sign so that the camp may use content from the Wild About Wildlife camp. Your camp coordinator's registration allows them to connect to and access the Wild About Wildlife Virtual Summer Camp content and livestream lesson offerings using a single device.
- 2) Wild About Wildlife Virtual Summer Camp will not be require the input of any personal information on the various third-party video conferencing and video streaming platforms. If you camp coordinator is asked to provide a name, they can provide their first name and last initial only.
- 3) The offerings hosted on live video conferencing platforms will have a representative from one of the environmental partners presenting content to attendees.
- 4) Some of these sessions may be recorded for future camp or class activity purposes and for children who were unable to attend that session.
- 5) Wild About Wildlife Virtual Summer Camp partners will monitor their respective offerings to ensure all campers have a safe and fun learning experience. All participants are required to adhere to responsible and appropriate behavioral expectations throughout each session. Wild About Wildlife Virtual Summer Camp representatives and content presenters reserve the right to remove participants who do not adhere to these expectations from the virtual summer camp. However, we are not responsible for the actions of attendees. *We encourage parents and guardians and/or camp coordinators to monitor children while using the various platforms.*

The Wild About Wildlife Virtual Summer Camp may include some physical activity from time to time. The exercise sessions may range from one minute to approximately 30 minutes in length and will be led by a certified yoga teacher.

MINOR CHILD CONSENT, RELEASE AND WAIVER OF ALL LIABILITY (“Release”)

NOTICE TO THE MINOR CHILD’S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF MANATEE LAGOON – AN FPL ECO-DISCOVERY CENTER, MOTE MARINE LABORATORY, AND LOGGERHEAD MARINELIFE CENTER (COLLECTIVELY, “ENVIRONMENTAL PARTNERS”) USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD’S RIGHT AND YOUR RIGHT TO RECOVER FROM RELEASEES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND ANY RELEASEE HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

I, as the parent or legal guardian of below-named minor child, give permission and understand that my child will be participating in the Wild About Wildlife Virtual Summer Camp Series (hereinafter “Camp”), which includes voluntary physical exercise sessions, which may extend up to 30 minutes in length as part of participation in the Camp. I further understand that the Camp and exercise sessions are offered by the Environmental Partners, which are several educational centers in Florida contributing curriculum and activities to the Camp, and that sessions will either be in a recorded or live format, led by a certified yoga teacher and other specialized instructors.

I understand and agree there are possibilities of injury or other complications, including but not limited to musculoskeletal injuries, cardiovascular trauma, neurological impairment, heart attack and even death, which may occur while participating in any fitness, wellness, or other activities offered during the Camp. As the parent or legal guardian of the below-named child, I understand and agree that these activities are not commercial and on behalf of myself and my child, I voluntarily assume all risks associated with my child’s participation in yoga stretches or sessions and all activities of the Camp. I understand and acknowledge that it is my responsibility to ensure that my child participates prudently in the Camp and does not exceed any exercise or health guidelines established for my child by his or her physician.

I understand that my child’s participation in fitness, wellness, or other Camp activities is strictly voluntary and that I may discontinue my child’s participation at any time.

Since the Camp program may involve seeing other participants on screens, I understand that the Environmental Partners take no responsibility for what may be present in the background of those screens or the actions of other participants, and I will review what my child is seeing. If necessary, I will

alert Camp representatives if I am concerned about the background and/or I will terminate my child's participation.

In consideration for my child stated below being allowed to participate in Camp fitness, wellness, or other activities, I hereby release, and agree to defend, indemnify, and hold harmless the Releasees from any and all claims, demands, actions, or causes of action whatsoever, and from any and all liability for any loss or property damage or personal injury of any kind, nature, or description, including death, that may arise or be sustained by my child, during or related to my child's participation in the fitness, wellness, or other activities offered by the Camp.

I understand and agree that the Camp's live sessions may be recorded and used by the Camp for educational purposes, and that my email address may be shared with all Environmental Partners.

I hereby represent that I have read and understood all the foregoing and acknowledge that this Release is being relied on by Environmental Partners in permitting my child to participate in Camp fitness and program activities. I understand that at any time I may review this release by requesting a copy from the Camp staff.

I hereby certify that I am the parent or legal guardian of the child/children within this online camp registration, and I do hereby give my consent without reservation to the foregoing on behalf of these children.

IMAGE USE AND PERMISSION

I hereby grant the Environmental Partners an irrevocable, perpetual and royalty-free right to record, use, reproduce, sell, sublicense, duplicate, edit, display, transmit, publish and otherwise make use of the Participant's likeness, picture and/or voice now or hereafter known for use in print advertising, television, internet web sites, training materials, recorded messages and/or video recordings (collectively, the "Works").

I understand that Participant(s) may have the opportunity to share photos of projects and/or photos of themselves doing activities during the virtual camp sessions, and these photos may be repurposed by the Environmental Partners for future activities and shared with the public and/or other camp participants.

On behalf of the Participant(s), I hereby knowingly and voluntarily waive, release and forever discharge each of the Releasees from any and all actions, causes of action, costs, expenses, damages, losses, liabilities, and demands (including attorney fees and costs actually incurred), of whatever character in law or in equity, known or unknown, that arise out of or relate to use of the Works by the Releasees, including, without limitation, any claims for libel and/or invasion of privacy. On behalf of the Participant(s), I also hereby waive any right to inspect or approve the finished photograph or advertising copy or printed matter that may be used in conjunction therewith or to the eventual use that it might be applied. I understand that pictures of the Participant(s) may be altered or modified.

It is understood and agreed that the Environmental Partners shall retain all right, title and interest in the original Works, as well as any modification, derivative works or improvements made to the Works by the Environmental Partners. I also hereby grant the Environmental Partners permission to copyright, use, publish and/or republish the Works in any type of media.

I acknowledge that I (a) am 18 years of age or older and (b) have the capacity to sign and be bound by the terms and conditions of this Release on behalf of all Participants, and reaffirm that it is my definite and firm intention that this Release shall be binding upon myself, my heirs, my spouse, my children, my personal representative, my guardians, my executors, my legal representatives, my assigns and anyone else who might otherwise have the ability to make a claim or file a lawsuit on my behalf or on behalf of my estate. I further acknowledge that I have read Release and represent that I understand the contents of this Release before I affixed my signature (electronic or otherwise) below. I further agree to hereby waive my right to make any monetary or any other claim against the Environmental Partners for the use of the Work as provided herein.
